4b (Code:) (Expenses \$ 63,913 including grants of \$ 59,100) (Revenue \$) Compassion Care - In 2021, River House Global continued to fund a children's home in India ran by a local organization. The home provided complete care for 70 children including housing, food, medical care, education and more. The organization broke ground on the second children's home and completed the ground floor construction.

4c (Code:) (Expenses \$ 23,017 including grants of \$ 18,204) (Revenue \$) Evangelism Initiative - River House Global provides leadership equipping and training through pastoral and leadership meetings and conferences throughout various cities, primarily within India. Spiritual meetings and conferences are hosted for local communities and churches. The organization hosted five pastoral conferences, serving over 1,000 pastors and leaders. Partens also launched 2 new churches.
