Spiritual meetings and conferences are hosted for local communities and churches. The organization planted a new church with 1500 members. Partners also launched five new churches and 10 acres of farm land were purchased for ministry purposes.

Compassion care - In 2022, River House Global continued to fund a childrens' home in South Asia ran by a local organization. The home provided care for 112 children including housing, food, medical care, education and more.
